### Notes:-

1. The Company's application for delisting of its Equity Shares from Stock Exchange at Kolkata is still pending.
2. The Company is in the business of cultivation, manufacture and sale of tea which is seasonal in character and as such the foregoing figures should not be construed as being representative of the likely result for the full year. The Company is also engaged in the business of oil and gas exploration.

3. The value of consumption of raw materials represents only green leaf purchased from estate not belonging to the Company. As the production of green leaf (raw materials consumed by the Company for the manufacture of Tea) from the Company's own estates involves integrated process having various stages such as nursery, planting, cultivation etc., their values at the intermediate stage could not be ascertained.
4. As regards non – ascertainment / non – provision of Fringe Benefit Tax, the Company has obtained interim stay from the Hon'ble Gauhati High Court against imposition of Fringe Benefit Tax, vide the Writ Petition WP(C) No. 557/2006 filed before it.
5. In terms of the amended Clause 41 of the Listing Agreement, details of number of investor complaints for the quarter ended 30<sup>th</sup> September, 2007 as per Certificate received from the Company's Registrars & Share Transfer Agents, M/s.
